### DIRECTIONS

Clean parts of any dirt, soil, rust or scale prior to applying Metal Kote.

Shake the can well prior to spraying. Hold can 8 to 10 inches away from application point. Apply in a slow, steady sweeping spray. Saturate surface completely with product. For ultra harsh environments, apply a second coat after 5 minutes.

Total set up and cure time - two hours.

When coating is hard, it is ready to be handled.
